

## General Sweeps Official Rules (“Official Rules”)

**NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.**

By entering into this Sweepstakes, I accept the terms and conditions and set forth in these Official Rules. I confirm I am at least 18 years old and have reached the age of majority in my jurisdiction of residence at the time of opt-in (19 in Alabama and Nebraska; 21 in Mississippi). By entering the sweepstakes, I agree to sign up to receive newsletters and special offers from Katie Couric Media, LLC. tentree, Shore Magic, heywell, bande, Welly, Captain Blankenship, Blume, and GETMr. provided products (prizes) to the Sweepstakes but only Katie Couric Media, LLC is sponsoring the sweepstakes and responsible for operating the Sweepstakes. **Eligibility: Renew Your Routine** (the “Sweepstakes”) is open to anyone who is at least eighteen (18) years of age and has reached the age of majority in their jurisdiction of residence at the time of opt-in (19 in Alabama and Nebraska; 21 in Mississippi) and lives within the continental United States and has a valid email address. **How to Enter:** At the beginning of the Entry Period, you may enter the Sweepstakes by visiting the sweepstakes site [link.katiecouric.com/join/650/renewroutine](https://katiecouric.com/join/650/renewroutine) (the “Sweepstakes Site”) and completing the Sweepstakes entry form. There is a limit of one (1) entry per person/email address. The use of an agency or any automated system to enter is strictly prohibited and Sponsor reserves the right to disqualify any entries received through such methods, as determined by Sponsor, in its sole discretion.

By entering the Giveaway in accordance with the entry process described above, you will be registering to receive email communication from Katie Couric Media, LLC, in accordance with their Privacy Policy, a current copy of which can be found here <https://katiecouric.com/katie-couric-media-privacy-notice>.

**Drawing:** After the Entry Period, on or about 1/20/22, Sponsor will select one potential winners in a random drawing of all entries received. The odds of being selected depend on the number of entries received.

**Notification and Requirements of Potential Winners:** Sponsor will attempt to notify potential winners within five (5) business days of the drawing by email. If the potential winner does not respond within seven (7) calendar days after the notice is sent, the Sponsor will select alternate potential winners in their place at random from all remaining entries received. Only up to (25) alternate potential winners will be contacted. The "authorized account holder" is the natural person who is assigned to an email address by an Internet access provider, online service provider, or other organization responsible for assigning email addresses for the domain associated with the submitted email address.

**Use of Entrant Information:** By entering the Sweepstakes, you acknowledge and agree that Sponsor will use Entrant's information, including, without limitation, your email address, phone number, mailing address, or any other contact information provided for general solicitation, marketing, or other business or promotional activities in connection with the services and products provided by Sponsor or the participating companies. **Disputes:** Except where prohibited, you agree that any and all disputes, claims and causes of action arising out of, or connected with, the Sweepstakes or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate court located in New York, NY.
